6           affiliates and business connections throughout the APIL Region; and


7           **WHEREAS**, Bank of Guam; Continental Airlines; Matson Navigation Company; Pacific Islands Development

9           Micronesian Challenge supported the 26th General Assembly; and


10          **WHEREAS**, this support provided substantial assistance to the APIL and relieved the financial burden
