APIL Resolution No. 30-GA-19

- 1           **WHEREAS**, the 30<sup>th</sup> General Assembly of the Association of Pacific Island Legislatures  
2 was held in the Republic of Palau from June 15-17, 2011; and  
3           **WHEREAS**, the Palau National Congress (Olbiil Era Kelulau) graciously provided the  
4 support and logistics necessary for the conduct of the meeting and the requirements of those

6           **WHEREAS**, the esteemed members and staff of the Palau National Congress (Olbiil Era
