A RESOLUTION

APIL Resolution No. 34-GA-07

"Recognizing the urgent need to enact legislation and/or to establish guiding policies to provide for the organization of the Protected Areas Network for Micronesia and to effectuate the disbursement of funds from the Micronesia Challenge Endowment Fund and other sustainable revenue sources to Micronesian communities to improve the management of their protected areas."

1 WHEREAS, the Association of Pacific Island Legislatures (APIL) has endorsed the 2 regional Marine Protected Areas Network across the Pacific Islands in Resolution No. 25-3 GA-06, CD1; and 4 WHEREAS, in December of 2006, the Republic of Palau, the Federated States of 5 Micronesia, the Republic of the Marshall Islands, the Territory of Guam, and the 6 Commonwealth of the Northern Mariana Islands entered into a regional Executive 7 Consultation and Agreement entitled the "Micronesia Challenge" (MC); and 8 WHEREAS, the Micronesia Challenge is an integral component to our regional 9 success in conserving our marine and forest resources, protecting our environment for food 10 security and sustainable development for our people, and facilitating a uniform system for the 11 preservation and protection of protected areas on a regional level; and 12 WHEREAS, the Micronesia Challenge calls on participating jurisdictions to 13 effectively conserve thirty percent (30%) of near shore marine resources and twenty percent 14 (20%) of forest resources throughout Micronesia by the year 2020; and 15 WHEREAS, effective conservation under the Micronesia Challenge also includes the 16 establishment of sustainable financing in the form of an endowment fund and other organized 17 financing mechanisms such as Protected Areas Network (PAN) Funds and Green Fees that 18 will ensure the sustainable financing of the Micronesia Challenge; and

1 WHEREAS, Micronesian communities are ready to receive and utilize the 2 Micronesia Challenge Endowment Fund earnings to improve the management of their 3 protected areas; and 4 WHEREAS, disbursement of the proceeds from the Micronesia Challenge 5 Endowment Fund requires an organized structure for disbursement which can be 6 accomplished through the enactment of Protected Areas Network legislation and/or the 7 establishment of Guiding Policies; now, therefore, 8 **BE IT RESOLVED** by the Association of Pacific Island Legislatures, 34th General 9 Assembly, July 7-10, 2015, Island of Pohnpei, FSM, that the Association of Pacific Island 10 Legislatures hereby requests that all jurisdictions participating in the Micronesia Challenge 11 recognize the urgent need to enact Protected Areas Network legislation and/or to establish 12 Guiding Policies to provide for the organization of the Protected Areas Network for 13 Micronesia and to effectuate the disbursement of funds from the Micronesia Challenge 14 Endowment Fund and other sustainable revenue sources to the Micronesian communities to 15 improve the management of their protected areas; and 16 BE IT FURTHER RESOLVED that the APIL President shall certify and the APIL 17 Secretary shall attest to the adoption hereof and that copies of the same shall thereafter be 18 transmitted to the Chief Executives and Legislative Presiding Officers of each member 19 jurisdiction of the Association of Pacific Island Legislatures and to the President and the 20 Speaker of the Congress of the Federated States of Micronesia.
