A RESOLUTION

APIL Resolution No. 35-GA-07

"Congratulating the government and the people of the island of Guam for successfully hosting the 12th Festival of Pacific Arts on Guam, from May 22 to June 4, 2016."

WHEREAS, the Association of Pacific Island Legislatures, 35th General Assembly congratulates and thanks the government and people of Guam for successfully hosting the 12th Festival of Pacific Arts on Guam, held from May 22 to June 4, 2016. Twenty-seven Pacific islands and nations participated at the Festival of Pacific Arts, including all of the APIL members; and

WHEREAS, the Festival of Pacific Arts has been held every four years since 1972, and brings together artists and cultural practitioners from around the Pacific region for two weeks of sharing arts and culture. It is recognized as a major regional cultural event, and is the largest gathering in which Pacific peoples unite to enhance their respect and appreciation of one another; and

WHEREAS, the idea of a Festival of Pacific Arts was conceived by the Conference of the South Pacific Commission, now the Secretariat of the Pacific Community, (SPC), in an attempt to combat the erosion of traditional customary practices. Since 1972, delegations from twenty-seven Pacific island nations and territories have come together to share and exchange their cultures at each Pacific Arts Festival; and

WHEREAS, the 12th Festival of Pacific Arts on Guam received a delegation of 2,500 performers, dancers, artists and cultural practitioners, in addition to thousands of visitors and festival followers from neighboring islands and from Asia; and

WHEREAS, the twenty-seven Pacific island nations and territories that were expected to be in attendance at the Festival include: American Samoa, Australia, the Cook Islands, Easter Island, the Federated States of Micronesia, the Fiji Islands, French Polynesia, Guam (2016 Host), Hawaii, Kiribati, the Marshall Islands, Nauru, New Caledonia, New Zealand, Niue, Norfolk

Island, the Commonwealth of the Northern Mariana Islands, Palau, Papua New Guinea, the

2 Pitcairn Islands, Samoa, the Solomon Islands, Tokelau, Tonga, Tuvalu, Vanuatu, and Wallis and

WHEREAS, the 12th Festival of Pacific Arts participating delegations featured and showcased their Traditional Dance Performances; the Jamz House live musical performances; Literary Arts: Theatre; Literary Arts: Oratory and Spoken Word Poets; Literary Arts: Publications; Literary Arts: Performance; Literary Arts: Indigenous Languages; Literary Arts: Fashion; Visual Arts; Traditional Arts, Demonstrations and Exhibitions; Floral Arts; Culinary

Arts; Forums, Workshops and Seminars; and Culture, Arts and Sustainable Development in the

10 Pacific; and

WHEREAS, the island of Guam had won the bid to host the 12th Festival of Pacific Arts at the 10th Festival held in American Samoa in 2008; and it was during the 11th Festival of Pacific Arts, held on the Solomon Islands in July 2012, that Guam officially received the Festival flag; and

WHEREAS, the 12th Festival of Pacific Arts is another venue where APIL member islands and nations can thrive and share their beautiful Pacific island cultures and arts that define who they are as a people; now, therefore,

BE IT RESOLVED that the Association of Pacific Island Legislatures, 35th General Assembly, *Hagåtña*, Guam, June 1-3, 2016, does hereby, congratulate and commend the government and people of the island of Guam for successfully hosting the 12th Festival of Pacific Arts held on Guam from May 22 to June 4, 2016; and does further express its sincere gratitude to the 12th Festival of Pacific Arts 2016 Coordinating Committee under the leadership of First Lady Christine M.S. Calvo, Honorary Chairperson; Ms. Rose F. Ramsey, Festival Director; Mr. Jon Nathan Denight, Chairperson, as well as all the committee members, assistants and workers for all their hard work and time spent to organize and steer the 12th Festival of Pacific Arts; and

BE IT FURTHER RESOLVED that the APIL President certify and the APIL Secretary attest to the adoption hereof, and that copies of the same be thereafter transmitted to the Honorable Eddie Baza Calvo, *I Maga'låhen Guåhan* (the Governor of Guam); to the Honorable Judith T.
