A RESOLUTION

APIL Resolution No. 40-GA-03

"Expressing congratulations and commendation to the newly seated President, His Excellency Wesley W. Simina, and Vice President, The Honorable Aren B. Palik, of the Federated States of Micronesia."

WHEREAS, the Congress of the Federated States of Micronesia is a unicameral legislative body comprised of fourteen members elected to represent each of the four FSM states, and by Constitutional mandate, four members are elected as at-large-representatives of each state to serve a four-year term while the remaining ten members are apportioned by state population and elected to serve a two-year term; and

WHEREAS, under the FSM Constitution, the fourteen members of the unicameral FSM Congress elect a President and Vice President from among the four At-Large members of the FSM Congress; and

WHEREAS, on the 11th of May, 2023, the newly-elected 23rd Congress of the Federated States of Micronesia opened its Inaugural Session, and as a result of the Caucus, the 23rd FSM Congress elected Chuuk State-Senator, Wesley W. Simina, and Kosrae-State Senator, Aren B. Palik, as the 10th President and Vice President of the FSM nation, respectively; now, therefore,

BE IT RESOLVED by the Association of Pacific Island Legislatures, 40th
General Assembly, FSM State of Chuuk, October 18-20, 2023, that the members of
the Association of the Pacific Island Legislatures hereby extend our sincerest
congratulations and commendation to the newly seated President, His Excellency
Wesley W. Simina, and Vice President, The Honorable Aren B. Palik, of the
