A RESOLUTION

APIL Resolution No. 41-GA-13

"Expressing sincere gratitude and appreciation to the 37th Guam Legislature for collaborating and working in partnership with the Chuuk State Legislature in hosting a Learning Exchange Program for Chuuk State Legislature staff, and further recognizing the Guam Legislature for supporting the professional development and capacity building of the staff of the Chuuk State Legislature."

1 WHEREAS, the 37th Guam Legislature hosted a Learning Exchange Program for 2 five (5) staff of Chuuk State Legislature from June 25 to June 28, 2024; and 3 WHEREAS, the Guam Legislature welcomed the staff of the Chuuk State 4 Legislature with full support and treated them with the Chamorro hospitality; and 5 WHEREAS, the Guam Legislature allowed the staff of the Chuuk State Legislature 6 to learn and experience first-hand its operation and legislative procedure by giving the 7 Chuuk legislative staff access to its facilities and resources, and further allowing the staff 8 to directly participate in its plenary sessions under the immediate supervision and guidance 9 of its relevant staff; and 10 WHEREAS, the Learning Exchange Program allowed the staff of the Chuuk State 11 Legislature to share information and build network with their respective counterparts in the 12 Guam Legislature; and 13 WHEREAS, the Learning Exchange Program contributed to the professional 14 development of the staff individually and collectively as employees of a law-making 15 institution, and further contributed to the growth and standard of the Chuuk State 16 Legislature; and

1 WHEREAS, the Learning Exchange Program arranged between the Guam 2 Legislature and the Chuuk State Legislature demonstrated regional collaboration and 3 cooperation in strengthening human development and people-centered security; now, 4 therefore, 5 **BE IT RESOLVED** by the Association of the Pacific Island Legislatures, 41st 6 General Assembly, Republic of Palau, August 12-13, 2024, that the Association of the 7 Pacific Island Legislatures hereby expresses sincere gratitude and appreciation to the 37th 8 Guam Legislature for hosting a Learning Exchange Program and for supporting the 9 capacity development of the staff of the Chuuk State Legislature; and 10 **BE IT FURTHER RESOLVED** that the APIL President shall certify, and the APIL 11 Secretary shall attest to the adoption hereof and that copies of the same shall be thereafter 12 transmitted to the Chief Executives and Legislative Presiding Officers of each member jurisdiction of the APIL and especially to the Speaker of the 37th Guam Legislature for the 13 14 sharing, thereof with the many fine Senators and legislative staff which contributed their 15 time and efforts to the Learning Exchange Program.
