## **A RESOLUTION**

## APIL Resolution No. 42-GA-10

"Respectfully requesting the Micronesian Shipping Commission to review its regulatory policies in order to ameliorate the shipping situation and lessen the high cost of ocean freight services to, from, and between the island ports of the APIL Pacific."

1 WHEREAS, the Association of the Pacific Island Legislatures (APIL) recognizes the importance of ocean shipping services throughout the APIL Pacific as essential to the 2 reliable transport of goods and necessities to the businesses and peoples of our region; and 3 WHEREAS, this Association is cognizant of the fact that the Micronesian 4 Shipping Commission has been established and is responsible for the regulation and 5 licensing of commercial shipping operations and shipping routes within the seas of the 6 Federated States of Micronesia, the Republic of the Marshall Islands, and the Republic of 7 Palau; and 8 WHEREAS, it has come to the attention of the APIL that there is no current 9 westbound service from Pohnpei to Chuuk, Yap, Palau, or potential markets in Guam and 10 the Commonwealth of the Northern Mariana Islands without first transiting to Asia and 11 returning at significant cost and with extended transit times, which has contributed to limits 12 on regional trade and has hindered our jurisdictions' ability to ship exports to those 13 markets; and 14 WHEREAS, the APIL is cognizant of the fact that Guam is governed by the Jones 15 Act, which requires the use of United States-flagged vessels for shipping from the United 16 17 States mainland, thereby increasing shipping costs dramatically, and because Guam serves as the central hub for ocean freight in the region, those elevated costs are necessarily borne 18 by island jurisdictions throughout the APIL Pacific; now, therefore, 19

- 2 General Assembly, Commonwealth of the Northern Mariana Islands, October 28-29, 2025,
- 3 that the members of the Association of Pacific Island Legislatures hereby respectfully
- 4 request that the Micronesian Shipping Commission review its regulatory policies in order
- 5 to ameliorate the shipping situation and lessen the high cost of freight services to, from,
- 6 and between the island ports of the APIL Pacific; and
- 7 **BE IT FURTHER RESOLVED** that the APIL President shall certify, and the
- 8 APIL Secretary shall attest to the adoption hereof, and that copies of the same shall be
- 9 transmitted to the Chief Executive Officer of the Micronesian Shipping Commission and
- to the Chief Executives and Presiding Legislative Officers of each member jurisdiction of
- 11 the Association of Pacific Island Legislatures.
