A RESOLUTION

APIL Resolution No. 42-GA- 15

"Expressing the sincerest gratitude and appreciation of the Association of Pacific Island Legislature's (APIL) to the Northern Marianas Commonwealth Legislature, the esteemed Leadership and the People of the Commonwealth of the Northern Mariana Islands (CNMI) for their gracious hospitality in hosting the 65th APIL Board of Directors Meeting and the 42nd APIL General Assembly."

1 WHEREAS, the Association of Pacific Island Legislatures (APIL) convened its 2 65th Board of Directors Meeting and the 42nd General Assembly under the pertinent theme, 3 "Economic Development: Strengthening Local Economies, Health, and Welfare Throughout the Blue Continent," from October 27 - 29, 2025, on Saipan, in the 4 5 Commonwealth of the Northern Mariana Islands (CNMI); and 6 WHEREAS, the Leadership (both governmental and traditional) and the people of 7 CNMI extended an exceptional welcome to all visiting delegations upon arrival and all 8 throughout the APIL Board of Directors Meeting and the APIL General Assembly Meeting; 9 and 10 WHEREAS, the Northern Marianas Commonwealth Legislature and its dedicated 11 staff demonstrated exemplary support and commitment in providing the necessary logistical 12 and administrative support essential for the successful conduct of these significant 13 deliberations and to meet the requirements of all attending delegates; and 14 WHEREAS, the Executive Branch and the Legislature of the CNMI collectively

2 member legislature of the Association of Pacific Island Legislatures.
