14 now, therefore,

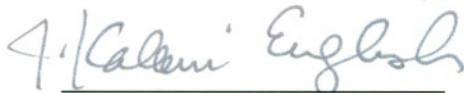
15 **BE IT RESOLVED** by the Association of Pacific Island Legislatures, 49th Board
