A RESOLUTION

"Congratulating WestCare Pacific Islands on its 5th Anniversary of its founding and highlighting its accomplishments in the region benefiting the people of Micronesia."

WHEREAS, WestCare Pacific Islands (WCPI) is a broad based, human services, non-profit 1 2 organization founded in 2009 dedicated to uplifting the human spirit by providing support to vulnerable 3 individuals and filling gaps in services on Guam and other Micronesian communities; and WHEREAS, WCPI is part of a national organization of non-profits with its Foundation offices 5 based in Nevada and services offered in 17 states, the Virgin Islands and the Pacific serving hundreds of 6 thousands of people each year; and 7 WHEREAS, WCPI has expertise in work with the homeless, those at risk of HIV/STD, persons with behavioral health and substance abuse issues, corrections, juvenile justice, and veterans; and 8 9 WHEREAS, training and technical assistance has been provided to various non-profit and 10 governmental entities on Guam, the Commonwealth of the Northern Mariana Islands (CNMI) and in the 11 Freely Association States (FAS) to assist in building capacity and strengthening organizational structures 12 to respond to the growing and expanding needs of the pacific communities; and WHEREAS, WCPI has provided support and extended its national and regional partnerships and 13 14 consults to many non-profits such as Payuta, Incorporated and the Micronesian Youth Services Network 15 (MYSN) to help them sustain their programs and activities so that these entities can in turn continue to
