A RESOLUTION

Resolution No. 61-BOD-01

"Extending to APIL's Past President, the Honorable J. Kalani English, the heartfelt wishes of the Board of Directors of the Association of Pacific Island Legislatures for your improved health and wellbeing as you seek to recover from the disabling effects of the COVID-19 virus."

1	WHEREAS, all of the APIL Pacific was shocked to hear the
2	distressing news that our Association's former President, our close friend
3	and our esteemed colleague, the Honorable J. Kalani English, was
4	announcing that he would be stepping down from his Senate seat in the
5	Hawaii State Legislature effective May 1, 2021, which correspondingly
6	meant that our former President would also be vacating his current seat on
7	the Board of Directors of the Association of Pacific Island Legislatures; and
8	WHEREAS, in what he has labeled as his final edition of his Senate
9	newsletter, Senator J. Kalani English graciously informed all of us that:
10	"In late November 2020, I contracted COVID-19
11	while with family out of Hawai'i. My symptoms
12	were mild and I did not physically suffer at the time
13	of infection from the virus, unlike many of our
14	friends and family. I was grateful to have healed.
15	Upon my return to Hawai'i, I noticed a change in
16	my energy, pervasive lethargy, memory challenges
17	and a fogginess in my thought process. I was not

sure what to make of the challenges and thought I 1 was suffering from depression or issues related to 2 depression. Having been deemed a long hauler, I 3 was diagnosed with long-term effects of COVID-19. My new normal will require me to address some of 5 the challenges left to my short and long-term 6 memory and other cognitive issues derived from the 7 virus. These challenges have placed a number of 8 things into perspective for me, including the need to 9 take better care of my health."; and 10 **WHEREAS**, we all remember with fondness and respect that during 11 his long and productive participation in the work of the APIL, our Past 12 President J. Kalani English brought to our attention and led us to address 13 many serious issues of regional importance touching all of the island 14 jurisdictions of the APIL Pacific; and 15 **WHEREAS**, it was not only in the General Assemblies and Board 16 meetings of our Association where the presence of our Past President J. 17 Kalani English will be so sorely missed, but it was his many visits to our 18 island communities and his many concerned phone conversations and 19 informative e-mails that remind us how central our former APIL President 20 has been to legislative progress in the APIL Pacific; now, therefore, 21

- shall certify, and the APIL Secretary shall attest to the adoption

- and to the Chief Executive and Legislative Presiding Officers of each
- member jurisdiction of the APIL.
