1           **WHEREAS**, on April 5<sup>th</sup> and 6<sup>th</sup>, 2023, the 62<sup>nd</sup> APIL Board of Directors  
2 Meeting was held in the State of Kosrae; and

3           **WHEREAS**, the Kosrae State Legislature and its staff have graciously provided
