**APIL Resolution No. 64-BOD-02**

**“Conveying gratitude and thanks to the Republic of the Marshall Islands for hosting the APIL 64th Board of Director’s Meeting.”**

2           **WHEREAS**, the Association of Pacific Island Legislatures (APIL)  
3 convenes its Board of Directors to discuss vital regional issues, promote unity, and  
4 strengthen legislative cooperation within the Pacific Islands; and

5           **WHEREAS**, the Republic of the Marshall Islands (RMI) has graciously  
6 hosted the 64th Board of Directors Meeting from February 25-26, 2025, at Nitijela  
7 Chamber, Majuro Atoll, Republic of the Marshall Islands providing an opportunity  
8 for meaningful deliberations and collaboration among Pacific Island legislators;

10           **WHEREAS**, the Republic of the Marshall Islands' hospitality and  
11 commitment to the APIL's mission are deeply appreciated, and their support of  
12 regional legislative engagement has been invaluable to the success of this  
13 gathering; now, therefore,

14           **BE IT RESOLVED** by the Board of Directors of the Association of  
15 Pacific Island Legislatures, 64<sup>th</sup> Board of Directors Meeting, Majuro, Republic of  
16 the Marshall Islands, February 25-26, 2025, that:

17           1. The Board of Directors hereby expresses its deepest gratitude and thanks to  
18 the Republic of the Marshall Islands for their exceptional hosting of the  
19 64th Board of Directors Meeting;

1        2. The Board acknowledges the hard work, resources, and time dedicated by  
2        the Government of the Republic of the Marshall Islands and the people of  
3        the Marshall Islands in making this meeting a success;

4        3. The Board affirms its commitment to continuing collaboration with the  
5        Republic of the Marshall Islands and all APIL members in addressing the  
6        challenges and opportunities facing our region; and
