## A RESOLUTION

### APIL Resolution No. 64-BOD-03

**“EXPRESSING DEEP GRATITUDE TO THE REPUBLIC OF THE MARSHALL ISLANDS FOR THEIR WILLINGNESS, GENEROUS HOSPITALITY, AND SUCCESSFUL HOSTING OF THE 2024 MICRONESIAN GAMES.”**

1           **WHEREAS**, the Republic of the Marshall Islands successfully hosted the 2024  
2   Micronesia Games, a prestigious regional event that brought together athletes, officials,  
3   and visitors from across the Micronesia, fostering unity, sportsmanship, and cultural  
4   exchange; and

5           **WHEREAS**, the Government of the Republic of the Marshall Islands and the  
6   people of the Marshall Islands demonstrated unparalleled generosity and warmth in  
7   welcoming all participants and guests, ensuring the success of the games and creating an  
8   atmosphere of friendship and celebration; and

9           **WHEREAS**, the hospitality and unwavering commitment to excellence shown by  
10   the Government of the Republic of the Marshall Islands and their people are deeply  
11   appreciated by all who attended the Micronesia Games; now, therefore,

12           **BE IT RESOLVED** by the Board of Directors of the Association of Pacific  
13   Island Legislatures, 64<sup>th</sup> Board of Directors meeting, Majuro, Republic of the Marshall  
14   Islands, February 25-26, 2025, that:

- 15           1. The Board of Directors extends its most sincere appreciation to the Government  
16           of the Republic of the Marshall Islands and the people of the Marshall Islands for  
17           their outstanding hospitality in hosting the 2024 Micronesia Games.
- 18           2. The Board acknowledges the tremendous effort and resources invested in  
19           ensuring the success of the games, from the planning stages to the seamless  
20           execution of the event, and recognize the spirit of generosity that made every  
21           guest feel welcome and valued.
- 22           3. The Board affirms that the warm hospitality and exemplary leadership displayed  
23           by the Government and people of the Republic of the Marshall Islands continue to  
24           inspire and strengthen the bonds of friendship and cooperation among Pacific  
25           nations; and

1           **RESOLVED FURTHER** that the APIL President shall certify, and APIL  
2   Secretary shall attest to the adoption hereof and that copies of the same shall be thereafter  
3   transmitted to the President of the Republic of the Marshall Islands, to the Speaker of the  
4   Nitijela and to the Chief Executives and Legislative Presiding Officers of each member  
5   jurisdiction of the APIL.
