A RESOLUTION

APIL Resolution No. 64-BOD-04

“AUTHORIZING APIL’S NEW OFFICERS TO BE ADDED AS NEW SIGNATORIES ON THE APIL BANK OF GUAM ACCOUNT AND RETIRING ONE OF ITS FORMER OFFICERS FROM THE SIGNATORY LIST.”

1 **WHEREAS**, “Authorizing APIL’s New Officers to be added as new signatories
2 on the APIL Bank of Guam account and retiring one of its former officers from the
3 signatory list.”

15 a signatory on the account; and

16 **WHEREAS**, Nelson Stephen is the retiring officer from the account; now,

1 **BE IT RESOLVED** by the Board of Directors of the Association of Pacific
2 Island Legislatures, 64th Board of Directors meeting, Majuro, Republic of the Marshall
3 Islands, February 25-26, 2025, that the members of the Association of the Pacific Island
4 Legislatures (APIL) authorize APIL's New Officers to be signatories on the APIL Bank
5 of Guam checking account as well as retiring one of its former officers from the signatory
6 list; and
